ORGANIZATION OF REVIEW MATERIALS

The package of materials includes several components, related through cross referencing. The following is a brief description of each plus the cross referencing conventions.

Primary Documents (distributed to all reviewers):

- **Narrative:** The document you are now reading. It includes a narrative statement along with supporting appendices, including sample teaching materials and five selected publications.
- **Publications:** This includes copies of all my academic publications. Individual publications are referenced using the name of the first listed author plus year of publication, enclosed in square brackets as follows: [Martini 97b] indicates my second-listed paper in 1997; [Sause 91] references a 1991 paper in which Professor Sause is the first-listed author. The full list of publications is included at the end of the Narrative, and at the beginning of the Publications document.

Supporting Documents (distributed to UVa reviewers only):

- **Teaching:** This contains teaching materials and samples of student work.
- **Documentation:** This includes letters, email messages, memos and other documentation that support points made in the Narrative. Items are referenced using square brackets including the author and the date, using the format YY.MM.DD; e.g. [Spivey 97.10.01] refers to an email message from Mr. Spivey on October 1, 1997. For citations from quarterly publications, the cross reference uses two-letter abbreviations to designate the quarter, e.g. [Explorations 98.SP] for the Spring 98 edition of the publication *Explorations*.
- **Web Logs:** This is a compilation of organizations that have visited my various web sites in 1997 and 1998, along with statistics describing the volume and nature of their traffic. This document supports the discussion in Appendix G in the Narrative.

Supporting Electronic Documents (available to all reviewers):

- **Review Web Site:** This is a web site with a series of links organized as an appendix to support the Narrative. The address is:

Links on the Review Web Site are assigned numbers based on a hierarchic outline, and these numbers are referenced from the Narrative (e.g. the course web site for *Structural Design for Dynamic Loads* is available from link 1.2 of the Review Web Site). A printout of the Review Web Site is included in Appendix N of the Narrative.
